NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Walton County, Florida, as follows:

1. Authority; Intent. Pursuant to Chapters 22 and Chapter 23 of the Walton County Code of Ordinances, the Board of County Commissioners is authorized to set and amend, as necessary, the fees and fines for those designated activities and violations, and to suspend and revoke permits issued under those Chapters. The Board of County Commissioners has determined that it is in the best interest of the citizens of Walton County, tourists, local businesses and the

overall economic benefit of Walton County to establish fees for permits, fines for certain uncontested violations of Chapters 22 and 23, Walton County Code of Ordinances, and points-based penalties for violations of those Chapters and suspensions and revocations of permits based on the accumulation of points and specified offenses. Nothing in this resolution can or is intended to affect judiciary discretion in setting fines for any contested violation or to order a violator to pay costs of a contested proceeding.

- 2. Establishment of Fees. The following fees are set and may be amended by the Board as necessary for activities permitted as follows:
 - a. Dog on Beach \$30.00 per dog plus \$10.00 processing fee
 - b. Fire \$50.00 per 24 hours
 - c. Beach Driving Permit (all amounts shall have a \$10 processing fee added thereto):
 - i. Private Vehicle \$125.00
 - ii. Private Trailer \$30.00
 - iii. Charter Vehicle \$200.00
 - iv. Charter Trailer \$30.00
 - v. ATV Private Security \$100.00
 - vi. Bay Charter/Launch \$250.00
 - d. Beach Special event
 - i. \$50.00 for less than 10 people
 - ii. \$150.00 for 10 to 30 people
 - iii. \$250.00 for 31 to 50 people
 - iv. \$500.00 for 51 to 75 people
 - v. \$1,000.00 for 76 or more people
 - e. Developments with commercial entitlements shall submit a calendar of events for the calendar year and be subject to a fee of \$1,000.00 per calendar year.
 - f. The fee for non-profit organizations shall be waived upon showing proof of the organization's non-profit or tax exempt status.
- 3. Beach Vendors (separate permit required for each category of operations):
 - a. Chair & Umbrella:
 - i. \$1,000.00 for initial location
 - ii. \$250.00 for each additional location
 - b. Water Based Activities:
 - i. \$1,000.00 for initial location
 - ii. \$250.00 for each additional location
 - c. Personal Watercraft Operations:
 - i. \$1,000.00 for initial location plus
 - ii. \$250.00 per vehicle
 - iii. \$250.00 for each additional location
 - d. Parasail Operations:
 - i. \$1,000.00 plus \$1000.00 per location

- e. Miscellaneous Operations (anything not covered above):
 - i. \$250.00 per type and location
- 4. Establishment of Fines. The following fines are set and may be amended by the Board as necessary. For uncontested violations as indicated in the following chart. The fines are minimum fines and do not affect any fines or costs that may be incurred through a contested civil citation hearing.
 - a. Violations of Chapters 22 or 23 not otherwise listed below are as follows:
 - i. First violation \$100.00
 - ii. Second violation \$200.00
 - iii. Third and subsequent violations Fine up to \$500.00
 - b. Violations of Section 22-57(a) (driving on beach without a permit):
 - i. All violations \$500.00
 - c. Violations of Section 22-57 (p) (Driving permitted vehicle on beach after hours):
 - i. First violation \$100.00
 - ii. Second violation \$200.00
 - iii. Third and subsequent violations Fine up to \$500.00
 - d. Violations of section 22-54(b) (Fire on beach without permit):
 - i. All violations \$500.00
 - e. Violations of Section 22-54(a) (Overnight camping):
 - i. First violation \$200.00
 - ii. Second violation \$300.00
 - iii. Third and subsequent violations Fine up to \$500.00
 - f. Violation of Section 22.54(g)(2) (c): (State of emergency):
 - i. All Violations \$500.00
 - g. Violation of Section 22.54(h)(3) (Double red flag violation):
 - i. All violations \$500.00
 - h. Violation of Section 22.54(b)(2) (Failure to clean up after bonfire):
 - i. All violations \$500.00
 - Violation of Section 22-57(b) (Failure to permanently affix decal to vehicle):
 - i. First violation \$200.00
 - ii. Second violation \$300.00
 - iii. Subsequent violations Fine up to \$500.00
 - j. Violation of Section 22.60(b) (Vending without a permit):
 - i. All violations \$500.00
- 5. Adoption of beach vendor permit suspension/revocation process. The Board of County Commissioners hereby adopts the following table in its entirety as the process for suspending and revoking beach vending permits:

- 6. Non-Exclusive Remedy. The points-based suspension/revocation process above shall not be deemed an exclusive method of suspension, revocation, or denial of beach vending permits, and the Board of County Commission may adopt any and all other methods and manners it deems appropriate, however, the adoption or utilization of any such other manner or method shall not serve as a basis for any defense against the process set forth herein.
- 7. Severability. If any provision or portion of this Resolution is declared by any court of competent jurisdiction to be void, unconstitutional, or unenforceable, then all remaining provisions and portions of this Resolution shall remain in full force and effect.
- 8. Effective Date. This resolution shall be effective immediately upon adoption by the Board of County Commissioners.
